

I studied this book religiously. I got no less than 90% correct on all the practice exams, and then proceeded to bomb the exam. Obviously the material does not track the exam very well. It's cheap, but its true value is even less than the price. Don't buy it. (On the positive side, it had some interesting discussions of the law; but it simply does not track the content of the exam.)

This is a great study book for passing the Real Estate Salesman exam. I haven't finished studying yet. But the chapters I have studied are easy to comprehend. It's not like reading through the Primer, which is insanely dull and difficult to comprehend. This text is very well organized and I know it will help me pass the exam when I feel I am ready.

I studied this book for my first broker's exam on December 14, 2005 at the Pasadena Center and failed. I solved and reviewed twice all the chapter problems and all of the exam sets in the book. I was very confident that I could answer correctly on all the questions in the book. But the questions on the actual exam were nothing like the ones in the book. The questions on the actual exam were much longer and harder. They required much deeper knowledge than what the book presented. It was like the authors never have seen the actual exam. This is a real estate knowledge book, not an exam prep book. I have wasted my time and money because of this book. What could an exam prep book do worse if a book not only does not help, but also misleads about the actual exam? Please do not buy this book to study for the exam. This is a shame on the famous name 'Barron's'. Do not be a victim like me. Hope my and my family's suffer would do some good by letting other people know not to buy this book.

I bought this to study for the Broker' exam- (I originally passed the sales exam using Barron's) - I read and understood the content, and routinely scored in the mid 80's, low 90's on the practice exams. When I took the Broker's test- the CA state exam questions were much more difficult and sophisticated, and I had a lot of difficulty with them. I've never failed to pass a test in my life, and got a 69% on the CA Broker's exam. This is a great book for the sales test, NOT SO GOOD for the Broker's test.

For those who are getting into the Real Estate profession or just want to know more this book will cover it. It include the sales aspect as weel as the broker license procedures. The book has 450 questions that you can review and answer. I find this a great reference book for taking the sales exam.

It might be great for the salesperson exam, but it just doesn't have the detail for the brokers exam. I have to take the test again.

This is a great book. It is easy to read and easy to understand. It has lots of ideas. Great for beginners as well as very experienced money makers

I see a lot of people who failed the exam with this book. Maybe I'm a rare exception but I used this book and passed the real estate sales exam. I will be taking the Broker exam next month and I'm going to turn to this book again. (By the way, its the same exam I jsut have to score higher)
