

Synopsis

This is an amazing story that is a must read for both healthcare professionals and patients alike. As a physician I know all to well that abuse of power can be a lethal mix in the quality care of patients. Unfortunately mistakes are a part of healthcare. However the stunning abuse of power that went unchecked with such an obvious physician out of control. Thank you Dr Harbin for presenting this story in such a succinct and elegant way. This should be a required reading for everyone taking care of patients as well as medical students. The lay person I think might have more difficulty following the sequence of events primarily because most would find it hard to believe physicians would act like many in the book. However after reading this book I expect patients will better able to protect themselves. Great read!

I picked up Dr. Harbin's book and found myself putting it down 8 hours later, minus a night of sleep. Although the events related in the novel should be terrifying to the average reader, relating them with an appropriate level of detail and integrity is an enormous challenge for the author. I lived through the aftermath of some of these events and can even remember a patient who traveled up from Atlanta to Baltimore for eye surgery saying that she made the trip to ensure that the proper eye would be operated on. Harbin sifted through weeks of testimony, transcript, and legal proceedings but managed to maintain a breathtaking pace and timing throughout. Although the events portrayed are monstrous and may induce a sense of outrage in the reader, Harbin is careful to be an objective relator. The result is a tragedy of Shakespearean proportions. Nobody comes out unscathed. Not the perpetrators, not the whistleblowers, and certainly not the patients who were harmed. Although the events described occurred 25 years ago, human nature being what it is, we must continually ask

ourselves whether we have adequate safeguards in place to prevent recurrence. Clearly, patient safety has become a priority at every major medical center. Extensive procedures have been instituted nationwide to prevent wrong eye (along with wrong-leg, wrong-hand, etc. surgery). The precipitating event of this book was not an isolated accident in its day, nor was it limited to Emory, as National Institute of Medicine Studies have shown. Not only are avoidable medical errors less likely today, Universities have grown far less tolerant of potentially fraudulent billing practices, as a result of huge public settlements paid by major teaching hospitals to reimburse the Medicare program for past practices. Lastly, there is substantially more protection for those whose ethics compel them to question potentially inappropriate and abusive practices, along with an established investigative structure that is less likely to whitewash an allegation. What hasn't changed is the human capacity for evil, especially when motivated by greed. It plays out in our headlines every day. We are surrounded by it in our financial dealings. We see it play out in the legal profession, within religious institutions, and we expect it in politics. Perhaps what is most remarkable about Harbin's book is that we find it shocking when ordinary, pedestrian greed and evil surfaces within an academic medical institution. It is a remarkable tribute to medicine that society is surprised when human nature at its worst invades the medical citadel, while we have long-since ceased to be surprised when it invaded the corporate boardroom, the city council, the federal government, or even the local house of worship. At some level, it must be a tribute to the medical profession that the events related are exceptional to the point where they are compelling and worth reading about 25 years later.
