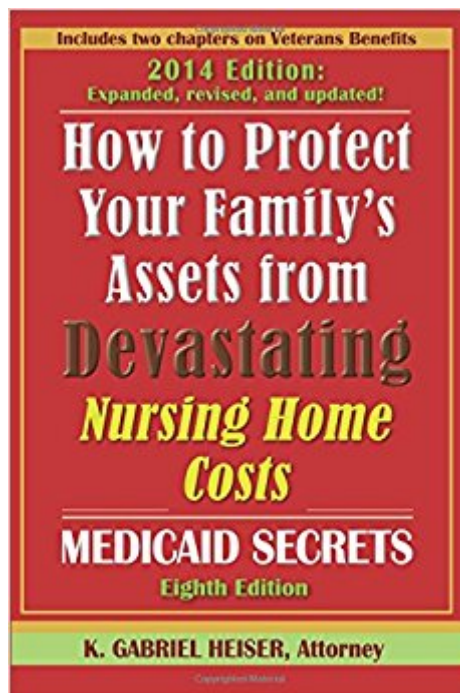

Many times the author states blurbs like, "Under the law of 29 states.." or "certain states allow", but neglects to tell us which states are applicable. It appears he updates this book every year, so why can't he be more specific. I just expected more.

Over and over the author advises that you cannot get through the maze without a good Elder Law Attorney. I had already seen an Elder Law Attorney and he had immediately set up a Durable Power of Attorney and new Wills. That is supremely important as stated in this book. The Attorney had also advised me to have him apply for Medicaid IF we ever needed it. He said it would cost us money but that he would save us SO much in the long run. After

reading this book, I understand what he was saying.... and I see how important it is. I have been so stressed about the "five year look-back" thing and learned that it applies to "gifts".
