The book is very wordy. The concepts concerning crowdfunding could have been presented in 50 pages or less. I think it would have been better for the author to focus only on crowdfunding instead of jumping into the topic of entrepreneurship. The author does seem to get a lot of research from other popular business books and Wikipedia. It does prescribe some kinds of an entrepreneurial process but it is too generic to be of any use (with most examples coming from other books). One thing that I found unusually is that after finishing reading the kindle version, the last page is a section from to recommend some extended readings (Ã¢ÂÂCustomers who bought this book also boughtÃ¢ÂÂ). The list seems atypical to me. Remedies for reluctant romantics by Tio StibA Sea of Dead by Robert FowlerLuck of the Devil: Book 1 by Jack CollinsFinding happy by Bev TaylorWriting Habit Mastery by S.J. ScottI wish I could upload the screenshot. None of them is related to crowdfunding nor entrepreneurship. So, people who read this book also like to read novels! I assume that the system is objective (based on actual purchases). The two things just don't add up. One potential explanation is that people who give this book 4-5 stars ratings are people who don't usually read business books and do not know the standard orÃ¢ÂÂ. This book is a great source of mostly basic information, both for the investor looking to make money through crowdfunding portals and for the entrepreneur attempting to gain seed capital to start or boost his business. I would have given it at least four stars, but the Kindle version (at least, I have not read the hard-copy version) is riddled with typos and graph errors. The book still manages to get its point across fairly succinctly, but the clarity is muddled by the fact that the editing is atrocious. If I had to guess, I would say I found a spelling or grammatical error in the writing every page or two. I can excuse one, or maybe a handful of typos, in a professionally edited book (I mean, everyone makes mistakes), but to be perfectly honest, I am startled by the number of errors I have found within the digital pages of this title. I would be more than willing to recommend this book to prospective investors and entrepreneurs that are new to the game and seek a basic overview of the new rules surrounding investment legalities, but I would also warn them that they will have to trudge through a myriad number of issues that cause the writing to appear choppy and unprofessional. With another go at editing, this book would bump itself up another star.
