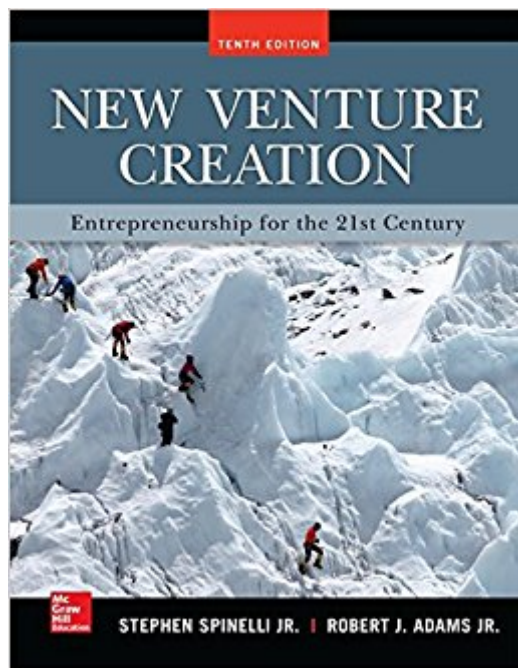

~The authors do not create an obvious tie between elements of the word formulas and the table data they are meant to compliment in the chapter on deal valuation, structure, and negotiation. Thus, formulas for figuring Ownership Dilution for rounds of financing, The First Chicago Method, Discounted Cash Flow, etc. are confusing to those who are not already familiar with these methods. The case files are thought-provoking exercises and are the best part of the book.
